

SUBJECT: Governance Committee Meeting Report – May 18, 2023

The Governance Committee of the Board of Trustees met remotely via Zoom on Wednesday, May 18, 2023, pursuant to Governor Baker's executive order of March 10, 2020, entitled "Order suspending certain provisions of the open meeting law, G.L., Ch. 30A, section 20," to allow public remote participation and participation of the public body remotely and extended by Governor Healey on March 29, 2023.

Present for the Committee were Trustees Butts, Maldonado and Mattera (chair). Also present and participating were President Keenan, Counsel Colucci and Board Secretary Montague

Chair Mattera called the meeting to order at 5:30 pm. The purpose of the meeting was to discuss the election of officers and the executive committee for AY2023-2024.
