

SUBJECT: Advancement Committee Meeting Report for March 20, 2024

In accordance with MGLA Chapter 30A and amended by On March 29, 2023, Governor Healey signed Chapter 2 of the Acts of 2023, which amongst other things, extends the remote meeting provision to March 31, 2025. other things, further extends temporary provisions pertaining to the Open Meeting Law to March 31, 2025. Specifically, this extension allows public bodies to continue holding meetings remotely without a quorum of the public body physically present at a meeting location, and to provide "adequate, alternative" access to remote meetings.

In accordance with the Open Meeting Law all votes taken during this meeting, in which a member participated remotely, were by roll call vote.

Present for the committee were Trustees Steve Immerman, Jim Lampassi Jr. (chair), Samanda Morales, President Keenan (ex-officio), Assistant Vice President Taylor Dunn, and Executive Assistant Hai Huynh.

Chair Lampassi Jr. called the meeting to order at 3:00 p.m.

Meet the Moment Campaign Update (presentation attached)

Vice President Webster Crounse submitted a written report on Advancement including a report on fundraising as of February 29, 2024 for the committee's review prior to the meeting. Assistant Vice President Dunn provided a campaign update on behalf of Vice President Webster Crounse.

Dunn reported that \$42,226,031 has been raised in the campaign as of March 15, 2024 with the following amounts in each priority: \$13.7M for unrestricted, \$16.6M for financial assistance, \$2.3M for SSU BOLD, and \$9.6M for student success. She shared that since the last committee meeting two endowed scholarships have been created in memory of faculty members who have passed: Professor John Fox and Professor Ellen Flowers. Dunn also highlighted the impact of comprehensive campaigns on the university by visualizing the cash transferred from the Salem State Alumni Association and Foundation to the university at key fundraising milestones over the last 15 years \$0.7M in FY2010 prior to the 10,000 Reasons campaign, \$2.2M in FY2018 after the 10,000 Reasons campaign and prior to the Meet the Moment campaign, and \$5.8M in FY2023 midday through the Meet the Moment campaign. She noted that the numbers are accrual based and include grants.

Dunn highlighted upcoming campaign events including the Internship Scholarship Fundraiser on April 9 at 7:30 am in Wakefield, Viking Warrior Day on May 1 and 2, and Alumni Weekend on June 7 and 8. The inaugural Internship Scholarship Fundraiser will be utilized to build a base of internship scholarships for students.

Dunn introduced White, assistant dean of student success, to present on the Bertolon School of Business internships impact in 2023. The internships were made possible by two donors, the Katmans and the Jameses. Dunn shared that \$35,300 in financial support was provided to 24 students in 2023. White highlighted that in 2023, 63 students completed internships with 32% students of color, 48 partner companies, and 100% completion rate. He shared that 38% of the internship students received financial support. White introduced Curristin, a student with a marketing concentration who currently interns at the North Shore

Chamber of Commerce. Curristin shared her experience and the value of having the opportunity to intern as she hopes to open a business of her own. She emphasized the importance of hands-on learning and how she has learned the high level of organization required to run your own business.

White concluded by introducing another experiential learning strategy, micro-internships, through technologies like Riipen. This is the next venture the business school will be deploying. Dunn noted that the work with micro internships is also made possible by an anonymous donor. This is an example of how philanthropy that helps the university be flexible and evolve academic offerings to our students.

There being no new business to come before the committee,

A motion was made by Morales, seconded by Wellman, and unanimously voted to adjourn the meeting. Lampassi Jr. asked for a roll call vote:

Advancement Brief

The primary focus of our March 20, 2024, Advancement committee meeting is to update the Board of Trustees on the Meet the Moment campaign.

Fundraising Report

Attached please find advancement's monthly fundraising dashboard as of February 29, 2024, where \$42,165,689 has been secured for the campaign. The Advancement team in partnership with donors has successfully secured new major gifts (\$50K+). Gifts of note since our last report to the Board:

- Received a \$53,660 gift from Ron Gillis '79 towards the Gillis Family Endowed Scholarship.
- Cristina Bita '00 committed \$57,000 to create the Professor John Fox Memorial Fund in memory of Salem State faculty member John Fox.
- The Murphy Family Scholarship was created with gifts totaling \$58,000 to support education majors by the children of Salem State faculty members, Dr. Jo-Anne D. Murphy, Ed.D. 1977 and William H. Murphy Jr.
- Received a commitment of \$150,000 from John McQuillan from Triumvirate Environmental, Inc. agreed to be the lead sponsor of the Internship Fundraiser in April and ongoing discussions are occurring about a transformational gift.
- An anonymous donor established a scholarship award in honor of Ellen Flowers, a long-time nursing faculty member who suddenly passed in January 2024. Ellen was also the Director of Psychiatric Nursing for Tewksbury Hospital and developed a specialized simulation training with the hospital for SSU nursing students.
- Alumni Association and Foundation Board of Director, Joanne Mendes gave \$33,333.34 to permanently endow the Joseph and Rena Mendes Scholarship and committed an additional \$8,750 to establish a spendable scholarship for immediate awarding in FY25/26.

Engagement

Advancement partnered with the Charlotte Forten Committee to plan the dedication of Charlotte Forten Hall, which welcomed 146 attendees, and on behalf of the Trustees, Trustee Samanda Morales '98 provided remarks.

The 7th anniversary of Viking Warrior Day, our annual day of giving and pride, will be held on May 1 and 2, 2024 Over the course of 1854 minutes, in honor of our founding year, alumni, parents, staff, students, faculty, and friends will come together in support of a better Salem State. This year, our goal is to raise \$325,000 and continue to increase donor participation.

We sent 261 fund reports for fiscal year 2023 (July 1, 2022-June 30, 2023) to donors who created endowed funds (169 reports), donors who have given \$5,000 or more to an

endowed fund (84 reports) and those who have created a fund via a planned gift (8 reports).

Endowment Market Value


Through the support of alumni and friends, the endowment held by the Salem State University Alumni Association and Foundation (AAF) exceeded \$50 million for the first time in the history of the Foundation.

Endowment Breakdown by Type

This chart represents the breakdown of the endowment by donor restriction as of June 30, 2023. For example, the portion that is scholarship, we have 181 endowed scholarships that make-up 37% of the endowment. In FY23, the AAF transferred \$958,986 in scholarships funds.

Additionally, a session on "Good Board Governance" included Chair Di Palma and Vice President Crounse with two other panelists from Oakton College.





Monthly Fundraising Dashboard Fiscal Year 2024






