**Salem State University**, the Awarding Authority, invites sealed bids from **DCAMM Certified Mechanical Contractors that also must be certified as Prime or General Contractors** for the **Campus Building Automation System Upgrades project, #SSU-2021-11B REBID** for Salem State University, Salem, Massachusetts, in accordance with the documents prepared by **Jones Architecture Inc.** dated **March 17, 2021**.

**Scope of Work:** The project includes the upgrading of Building Automation Systems (BAS) controls in multiple buildings on Campus.

The work is estimated to cost **\$854,000**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General Bids will be received until **11:00am, Wednesday, May 5, 2021** and publicly opened, forthwith online.

Filed Sub-bids are not required for this project.

All Bids should be submitted online at [www.biddocsonline.com](http://www.biddocsonline.com) and received no later than the date and time specified above.

General bids shall be accompanied by a **bid deposit** that is not less than five (5%) of the greatest possible bid amount (considering all alternates) and made payable to **Salem State University**.

Upon award of contract, a **100% Payment Bond** and **100% Performance Bond** will be required for the general contractor. Prevailing rates of wages apply and are included in the bid documents.

There is a plan deposit of \$50 per set (maximum of 2 sets) payable to BidDocs ONLINE Inc.

Deposits may be electronically paid or must be a check. This deposit will be refunded for up to two sets for general bidders upon return of the sets in good condition within thirty days of receipt of general bids. Otherwise the deposit shall be the property of the Awarding Authority.

Additional sets may be purchased for \$50

Bidders requesting Contract Documents to be mailed to them shall include a separate check for \$40.00 per set for UPS Ground (or \$65.00 per set for UPS overnight), non-refundable payable to BidDocs ONLINE Inc. to cover mail handling costs.
