Salem State University, the Awarding Authority, invites sealed bids from DCAMM Certified General Contractors for the Meier Hall Penthouse Walls Remediation project, #SSU-2022-03, for Salem State University, Salem, Massachusetts, in accordance with the documents prepared by Jones Architecture Inc. dated November 03, 2021.

Scope of Work: The project includes the waterproofing and installation of metal panel system at the penthouse of Meier Hall, replacing existing storefront windows and doors, removal and relocation of antennas above the penthouse, and interior renovations required to bring affected spaces up to ADA code.

The work is estimated to cost \$810,500.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General bidders must be certified by the Division of Capital Asset Management and Maintenance (DCAMM) in the following category of work -- **General Building Construction** and must submit a current DCAMM Certificate of Eligibility and signed DCAMM Prime Update Statement (Form CQ 3).

General Bids will be received until Wednesday, December 15, 2021 at 11:00 am and publicly opened, forthwith online.

Filed Sub Bids for the trades listed below will be received until Wednesday, December 08, 2021 at 11:00 am and publicly opened, forthwith online.

Filed sub-bidders must be DCAMM certified for the trades listed below and bidders must include a current DCAMM Sub-Bidder Certificate of Eligibility and a signed DCAMM Sub-Bidder's Update Statement.

General bids shall be accompanied by a **bid deposit** that is not less than five (5%) of the greatest possible bid amount and made payable to **Salem State University.**

Upon award of contract, a **100% Payment Bond** and **100% Performance Bond** will be required for the general contractor. Prevailing wages rates apply and are included in the bid documents

Deposits may be electronically paid or must be a check. This deposit will be refunded for up to two sets for general bidders upon return of the sets in good condition within thirty days of receipt of general bids. Otherwise, the deposit shall be the property of the Awarding Authority.

Additional sets may be purchased for \$50.
